#### NPEA POOL PRIVATE PARTY AGREEMENT - 2025

For after-hours pool party use, the undersigned pool party host agrees to the following:

### **Hours and Staffing:**

- 1. Minimum party length is two hours.
- 2. All activities must end by the designated time as specified in party contract
- 3. Party may not exceed 10:00PM.
- 4. Lifeguard ratio is 1 guard for every 25 people who are swimming.
  - a. The number of guards cannot be lowered once the contract is signed. Additional guards must be requested at least one week in advance of the party.
  - b. Host will be responsible for paying at least the number of guards indicated when contract is signed.
- 5. Party attendance may not exceed 100 people, maximum of 4 lifeguards.
- 6. If alcohol is served, it is mandatory to hire at least two lifeguards.
- 7. Inclement Weather
  - a. Inclement weather is defined as weather that makes the pool unsafe.
  - b. The 48 hour cancellation rule applies even to inclement weather.
- 8. Water Quality
  - a. NPEA Pool management determines if the quality of the water is safe to use. Pool usage for swimming could be cancelled at a moment's notice and host would be notified immediately.
  - b. Host can agree to continue to have the party using only the pool deck and covered areas and pay one lifeguard \$15.00 per hour to open and close the facility.
  - c. Host can decide to cancel and all fees will be refunded in full.

# **Host Responsibilities:**

- 1. Must be a pool member.
- 2. The Adult host must be on-site the entire time of the party.
- 3. The host is responsible for the conduct of all persons in attendance.
- 4. The abeyance and enforcement of all pool rules (as posted and/or as disseminated to pool members
  - a. The Host must sign and date a copy of pool rules to demonstrate that they know and understand all rules.
- 5. Set-Up
  - a. Host is allowed to bring any food, drink or decorations into the pool area.
    - i. The no-glass rule is ALWAYS in effect.
  - b. Host may not begin setting up in pool area until the pool is officially closed to members.
- 6. Cleanup of pool area after party.
  - a. Lifeguards will:
    - i. Stow furniture and umbrellas
    - ii. Ensure that bathrooms are clean
    - iii. Remove garbage bags to dumpster
    - iv. Perform any normal closing duties
  - b. The Host will:
    - i. Ensure that all trash and garbage is picked up.
    - ii. Remove any items brought into the pool area.
    - iii. Have a general patrol of pool area to ensure that it is acceptable.
- 7. The host is responsible for any and all damages that may occur during use of the pool facility.
- 8. Grilling is only allowed in the parking lot, not on the pool deck or in the covered area.

## **Pricing:**

- 1. Deposit is \$50.00 refundable fee
  - a. Due when contract is signed
  - b. This will be returned to the Host after the conclusion of the party if no other fees are assessed.
- 2. Two Hour Party Rental fee is \$100.00
  - a. Each additional hour is \$25.00 per hour

- b. Due when contract is signed.
- 3. Lifeguard Fee is \$15 per lifeguard per hour.
  - a. Cash or check due night of party paid directly to lifeguard(s).
- 4. Miscellaneous Fees
  - a. Overtime If party goes over the contracted amount of time, a fee of \$7.50 per half hour per lifeguard will be assessed. This will be taken out of the deposit. Please make sure to take this fee into account when cleaning up.
- 5. Refunds
  - a. Refund of fees will be given if pool use is canceled by verbal notice at least 48 hours prior to scheduled time.
  - b. If cancellation is less than 48 hours, lifeguard(s) will receive \$30.00 per guard

### **Alcohol Policy**
